Rules:

1. All participants must be USBC Youth Members and hold JOG membership. Membership may be purchased on site prior to the beginning of competition. (USBC Cert 07836)
  2. JOG spots will be offered in the following ratios for each division with the enhanced entry procedures offered for each division U12/U15: 1 in 4 U17/U20: 1 in 6
  3. Tournament will be bowled scratch
  4. Divisions are based on bowler age as of August 1, 2019. For the U12 &U15 Division bowlers must have a birth date between 8/1/07 or later & 8/1/04 – 7/31/07. For the U17 Division bowlers must have a birth date between 8/1/02 – 7/31/04. For the U20 Division bowlers must have a birth date between 8/1/99 & 7/31/02. **Bowlers are responsible for checking correct divisions. We are not responsible if bowler competes in the wrong division, No refunds.**
  5. All Divisions will bowl 6 games moving after each game. Winners will be determined by the highest scratch total after 6 games. Ties will be broken by a one game roll off.
  6. Multiple entries are not allowed.
  7. Bowlers participating in this tournament are not permitted to drink alcohol, smoke, or use electronic cigarettes during tournament competition.
  8. Returned checks are subject to a \$40 NSF charge.
  9. Dress code: Bowlers must wear their pants at the waist. Sweat pants and pants with holes or rips are not permitted. Bowlers must have a collared, V-neck, rib-lined, or banded neck. All shirts must have finished sleeves for all competition. Bowlers must be neat in appearance.
  10. All scoring errors must be reported within 24 hours. The tournament director will be the final authority unless appeal is filed under USBC rule 329.
  11. Entries must be paid and turned into Michelle Turner-Billings by February 16, 2020. Walk-ins per availability.
  12. A bowler arriving late may bowl, however any frames missed will be awarded a 0 score and frames cannot be made up.
  13. Any rules not covered will be governed by the USBC rule book.
