## 2021 'Denning - Sammons' Handicap Youth Championships USBC Certified (05654) Hndcp Division Div. A 140 & Up Hndcp Division Div. B 139 & Under

- 1. This tournament is certified by the United States Bowling Congress (#05654) and will be governed by the rules of USBC. Participants must be a DE USBC Youth member participating in a certified youth program in a Delaware bowling center. Minimum of 9 games. Handicap 90% of 230.
- 2. Participants in the Tournament must be neat in appearance and meet the following dress code rules:
  - A. Athletes must wear shirts with a collar similar to polo shirts. (official tee-shirts from youth bowling programs are acceptable)
  - B. Shirts must cover the entire midriff area or be tucked in. Shorts and skirts are allowed but must be no shorter than 2 inches above the knee. Pants must be worn at the waist or held there with a belt. **Torn or cut jeans, Yoga pants and Pajama pants are not allowed.**
  - C. No hats of any kind are permitted (except for religious reasons).
  - D. All clothing apparel must be of the correct size. (*Example: if your body size would normally wear a medium size shirt, a 2XL size shirt is not acceptable*).
  - E. Advertisements on apparel or bowling equipment depicting alcohol, tobacco, vaping, gambling or inappropriate language/gestures during tournament competition will not be allowed.
  - F. NO FOUL LANGUAGE ALLOWED OR YOU WILL BE DISQUALIFIED.
- 3. E-readers and I-pods will be permitted in the read only mode, or music only mode with reasonable volume levels. They will not be allowed on the lanes during bowling, but only in the settee area. *No cell phones, or handheld video games will be allowed.*
- 4. Competition will be conducted in 2 divisions based on the participant's average as listed below.

Division A 140 & Above

Division B 139 & Below

- 5. Association earned awards are based on the member's league average.
- 6. One lane courtesy will be observed to keep a consistent pace.

## Qualifiers & Finals Division A & Finals Divison B

- 7. All bowlers must check in at the tournament desk 30 minutes (½ hour) prior to schedule bowling time. At the qualifier, tardy/not present players will be permitted to bowl in competition, but will receive zero for all frames missed. At the finals, replacements may be used for bowlers not present 15 minutes prior to squad time. Replacements will be eligible based on order of finish in the qualifying round.
- 8. Bowlers will be allowed 10 minutes practice on their starting pair for qualifiers, and 2 balls on each lane for the finals. To keep a consistent pace, one lane courtesy will be observed
- 9. Only bowlers and tournament officials will be permitted in the settee area.
- 10. SCORING: Division A: Five game qualifier (moving pairs). After 5 games, the 1st thru 5th highest series and one alternate will advance to the step ladder finals following the qualifiers the same day. Total pins will be dropped from the qualifying round into the final round. Alternate will move into 5th seed if they are needed.
- 11. SCORING: Division B: Four game finals non-moving pairs.
- 12. TIES: If a tie occurs it will be broken by an additional ninth and tenth frame roll-off. (REFER TO RULE 326A)
- 13. Claims for errors in scoring or general playing rules must be made to the tournament director no later than the start of the next block of the tournament. Rule 329 allows for the filing of protests up to 72 hrs. after competition to the tournament director. Each protest under this rule must be specific in itself.
- 14. AWARDS: Symbolic awards will be given to each of the five finalists in Division A. Symbolic awards will be given in Division B at a ratio 1 in 10 or major fraction thereof.
- 15. Scholarship monies will be distributed depending upon the number of entries per division. Guaranteed scholarships are below. Scholarships will increase if there are more than 10 entries for Division A and for the Division B. Below is the guaranteed scholarships for each division:
