### Tournament Rules (Failure to read is no excuse)

1. **Eligibility:** This tournament is open to all certified Delaware USBC members from either association (or must become a sanctioned member in a Delaware Association before tournament starts)
2. **Format:** Is 3 games which are bowled on the same pair of lanes, team will consist of 3 women only.
3. **Official Tournament Entries:** Reserve entries close 4-1-22. Bowlers are responsible for verifying their own average. Failure to use the proper average, or make a correction PRIOR to the completion of the first game bowled will result in disqualification (USBC Rule 319) Average to be used in this tournament will be determined in the following order
  - a. Entrants shall use their highest certified average established in any USBC certified league book average/or bowl.com from 20-21 season if none then will use 19-20 season minimum of 21 games.
  - b. If player does not have a book average (from prvs 2 seasons) will use current average as of April 1, 2022. Bowler must provide average sheet for all leagues and use your current average.
  - c. Ten Pin Rule: if your current 21-22 average with 21 or more games is 10 pins higher than book average either season you must use your current average in this tournament. (USBC rule 319) this current average includes substitution averages
  - d. All other bowlers must bowl scratch 230.
  - e. Rule 319c will not be used
  - f. **Prize Reporting:** Bowlers who have qualified for \$600.00 or more in any tournament event or division of an event during 12 months prior to the time of entry, must attach a repost of money won in every case. Rerating average (RULE 319d) will not be used
4. **Handicap:** Division 1 - 581 and above handicap will be 90% of 230  
Division 2 – 580 and below handicap will be 100% of 230
5. **Substitutions:** Report all substitutes to the tournament manager at least 30 minutes prior to bowling. Once substitute throws their first ball for score, they must finish the event.
6. **Refunds:** No refunds will be permitted after squad is confirmed. However, in the event of an emergency, we will reschedule to another squad if possible.
7. **Check In:** Individuals must check in at least 30 minutes prior to squad time. Average & address verification must be submitted/confirmed.
8. **Scoring:** Once an event begins and a bowler is not there when it's their turn to bowl, a zero will be credited for every frame missed.
  - a. Automatic score sheets will be used as the official score sheet
  - b. Bowler must certify their scores as being correct at the completion of scores bowled. This will be the only opportunity for corrections
  - c. In case of scores being lost through the computer, re-bowling will be permitted.
9. **Awards:** The prize fund is returned 100% at a ratio of a minimum of 1 for every 5 entries per event.
10. **Protests:** The tournament manager will handle all protests. Tournament manager has the authority to accept or reject any entrant. All appeals will be handled in accordance with USBC Rule 329.
11. Unlimited participation is allowed. A team must change at least 1 person in the lineup if re-entering.
12. **Entry Fee:** is \$30.00 per person, breakdown as follows Prize fund \$15.00, bowling/expense \$15.00.
  - a. Checks, money order and cash will be accepted no credit/debit cards accepted.
  - b. Any NSF checks will disqualify team and there will be an NSF fee of \$45.00 on any returned check.

13. Send entry in early to get desired squad time (RECOMMENDED) Mail entries to 1001 Daisey Rd Clayton, DE 19938
14. Suitable looking attire must be worn. Skirts no more than 2 inches above the knee, walking/golf shorts, skorts, slacks, sleeveless shirts or clean jeans. No tank tops, bare mid-drifts or spaghetti straps. NO hats, caps or visors unless for religious reasons. Clothing with obscene logos or inappropriate language are not allowed. Final attire determination will be by tournament director.
